New Radiation and Asbestos Medicals

New arrangements have been made for radiation and asbestos medicals externally. Dr Bernard Kuenssberg has retired as Occupational Health Physician which affected the ability of the Occupational Health Unit

(OHU) to provide radiation and asbestos medicals by an HSE approved physician. The OHU have sourced an alternative provider for this service and the University has been registered with them. Therefore

any radiation or asbestos medical will now be done off campus and there will need to be a charge applied.

Chemical Safety — Globally Harmonised System

A new system of classifying, labelling and packaging of substances and mixtures has been introduced which aims to make all classification etc of substances harmonised the world over to reduce confusion and aid risk reduction measures. This system was implemented in the EU by the Classification, Labelling and Packaging of Substances and Mixtures Regulation (CLP Regulation) which came into effect 20 January 2009, subject to a lengthy transitional period. Most of the onus is on the Suppliers with regard to CLP but end-users will need to be aware of the changes in phrasing, pictograms and safety data sheets.

Health and Safety Law Poster

The Health and Safety Executive issued the latest revision of the health and safety law poster and leaflet on 6th April 2009. There is a five year transitional period for these and any previous versions of the poster and leaflet must be replaced by the new versions no later than 5 April 2014.

Eye tests for VDU use

University employees who are regular users of display screen equipment (DSE/VDU) should be made aware that, upon request, they will be provided with a vision test and eye examination - a DSE/VDU Eye test, by the appointed University Optometrist.

Employees who have been previously referred to the appointed University Optometrist or who already wear spectacles should contact the Health and Safety Office in the first instance by email Health.Safety@ed.ac.uk providing their Name, Department and Department address or by telephoning 651 4255 to obtain the necessary paperwork before arranging the appointment directly.



All other employees (any who have not previously been to the appointed University Optometrist and do not currently wear spectacles) should contact the Occupational Health Unit, 650 8190 to arrange an appointment for vision screening in-house. (Occupational.Health@ed.ac.uk).

The costs of such DSE eye tests will be met centrally, and Rodger and Smalridge will issue a prescription (where appropriate) to the applicant, and a report to Health and Safety Department, the latter stating whether sight correction specifically for DSE work is required. If a member of staff is prescribed a corrective appliance for DSE work, the School is responsible for the cost of up to £55 and will be informed of this via a letter from the Health and Safety Department.



Temperatures in the workplace

During the summer when ambient temperatures can reach the mid > high 20s °C for short durations, workplaces can get uncomfortably hot.

Currently health and safety legislation states that the temperature in indoor workplaces during working hours shall be reasonable, and the Regulations do not specify a minimum or maximum temperature. Generally the acceptable zone of comfort for most persons is roughly between 13°C (56°F) and 30°C (86°F).
