## University Health and Safety Policy

The University Health and Safety Policy has been reviewed and the new version officially launched at the recent Health and Safety Conference held in the Informatics Forum on 16th March 2016.

The Health and Safety Policy is issued upon the authority of the University Court. It is published in two documents - the University Health and Safety Policy and a Framework document, also divided into two - Organisation and Arrangements.

This policy replaces the Keynote Guide and 8 Parts of the previous policy and any local copies of the old versions should be destroyed and replaced with the new policy and any web links updated. The old 8 Parts of the Policy plus the Keynote Guide are still available online for reference only.

## Health Surveillance reminder

The Occupational Health Unit (OHU) provides a Health Surveillance Programme and participants are identified through risk assessment carried out by local management. Health surveillance does not minimise the identified risk, it checks the effectiveness of any controls & helps identify failures of the safety control system.

The Health Surveillance Programme identifies a date by which the surveillance is due and the individual must attend these appointments either on or before this date at the request of OHU. This should not be 'put off' or missed simply because of awaiting a clinic at your place of work. Staff are reminded that a missed appointment impacts on the ability to provide appointments for others and that regulatory compliance with statute can be put at risk.

Where the individual fails to attend a second offered appointment the individual will be noted as defaulting in the programme. The manager or PI responsible for the individual and the relevant local health and safety contact will be notified that the individual should not have further exposure to the source of risk.



## COSHH form and guidance updated

Section E - health monitoring, has been updated to give further guidance on when health surveillance may be required and how to determine if biological monitoring is required.

The accompanying guidance notes have also been updated to reflect this change.

## Revision of approved list of biological agents



The HSE Approved List of Biological agents which classifies biological agents hazardous to humans into hazard groups (HG) has been revised.

The revisions to the Approved List include re-classification of Zika virus (reclassified from HG3 to HG2), addition of Middle East Respiratory Syndrome coronavirus (HG3) and a new classification for type 2 poliovirus (HG3). When the type 2 component is withdrawn from the trivalent poliovirus vaccine, attenuated strains of type 2 poliovirus will also be classified as HG3. Types 1 and 3 polio virus will remain as HG2.
